Definition of Research

During the previous academic year, multiple academic leaders in the Academic Affairs Division, including the members of Academic Council, have reviewed a draft institutional definition of research, with the goal of providing more precision in our research-relevant institutional assessment efforts. I write today to indicate my final approval of a previously circulated research definition for use in the Academic Affairs Division and, further, to suggest this definition be used in any relevant assessment of research that occurs in other divisions of the College.

As background, the College's approved mission statement makes reference to the encouragement and support of research. The Faculty/Administration Manual explicitly recognizes the "teaching, research, and service functions of faculty" and makes provision for the evaluation of research activities, including creative activities, undertaken by individual faculty. Other policies of the College also acknowledge the College's research commitments.

In light of our previous review and discussion, and consistent with the authority given to me, I now approve the following definition of research for use at the College: "Research and creative activities in the liberal arts and sciences setting of the College of Charleston are defined as any intellectual, inquiry-based endeavors that advance knowledge and lead to new scholarly insights or the creation of new works in support of the College's educational mission."

SUBJECT:

Definition of Community/Public Service

During the previous academic year, multiple academic leaders in the Academic Affairs Division, including the members of Academic Council, have reviewed a draft institutional definition of community/public service, a term found in one of the current standards promulgated by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC). I write today to indicate my final approval of a previously circulated community/public service definition for use in the Academic Affairs Division and, further, to suggest this definition be used in any relevant assessment of community/public service that occurs in other divisions of the College.

As background, the College's approved mission statement contains no explicit reference to service, though the mission statement acknowledges in a general way the expertise of the faculty as "an important source of knowledge and expertise for the community state and nation." The mission statement also makes reference to the College providing "cultural activities for residents of the Lowcountry of South Carolina." The Faculty/Administration Manual explicitly recognizes the "teaching, research, and service functions of faculty" and makes provision for the evaluation of service activities undertaken by individual faculty.

In light of our previous review and discussion, and consistent with the authority given to me, I now approve the following definition of community/public service for use at the College: "The College of Charleston defines community/public service as any program that engages in mutually beneficial exchange of knowledge and resources with the community (primarily local, but not infrequently much more broadly defined) in a context of partnership and reciprocity."
